

TERMS AND CONDITIONS ZURICH MARATHON (ZH Marathon GmbH ; below organiser)

In consideration of the acceptance of my entry in Zurich Marathon I agree to observe the race regulations Zurich Marathon and of the management and organizers of this event (www.zuerichmarathon.ch).

- ✓ I hereby acknowledge that I have sole responsibility for my personal possessions and athletic equipment during the Zurich Marathon Virtual Run Event, and its related activities. I for myself and my heirs waive and release all claims against the organizers and any other person for loss or damage to objects. This is not applicable if the damage is subject to grossly careless or wilful action on the part of the organizers.
- ✓ I hereby attest and verify that I am physically fit and have sufficiently trained for this competition and that I will start the race in physically fit conditions.
- ✓ I hereby consent to receive, at my own cost, medical treatment that may be deemed advisable in the event of injury, accident and/or illness during the Zurich Marathon Virtual Run competition.
- ✓ I hereby permit the free use of my name, any images and other audio and video recordings in broadcasts, telecasts, the press, internet and in all types of printed material, including advertisements for this or other similar events, if the images etc. pertain to the Zurich Marathon Virtual Run.
- ✓ I hereby permit the free use of my electronically registered data for co-operation partners of the organization.
- ✓ I hereby release the organizers, managers and volunteers of the Zurich Marathon Virtual Run from any liability claims. Included herein are all direct and indirect damages and injuries I suffered or in the result of death. This is not applicable, if the damage or injury is subject to grossly careless or wilful action of the organizers, managers and volunteers.
- ✓ I hereby release those named in paragraph 6 from any liability against any other person, as far as this other person suffered any damage or injury during the race due to my participation in the Zurich Marathon Virtual Run.
- ✓ After checking the route including the transition areas, I confirm your suitability for my participation in the race. I also confirm that I comply with the SVG road traffic regulations.
- ✓ I expressly acknowledge and agree that the participation in the race Zurich Marathon Virtual Run could be dangerous and involve the risk of serious injury and/or death and/or property damage.
- ✓ I disclaim against the organizer, its employees and its servants from any compensation for damages to him or a third person that was caused due to the athlete being accompanied in any way up the finish line should by a person not registered for the race. This does not come to action if the damage was caused by gross negligence or malicious intent by the organizer, its employees and its volunteers. In case the damage is suffered by a minor, for whom the athlete has a caretaking obligation, the waiving also applies for those persons. In case of third parties claiming against the organizer, its employees and its volunteers due to the described events of a claim, the athlete commits himself to indemnify and hold harmless the organizer, its employees and its volunteers.
- ✓ I acknowledge that I may be required to submit to doping control tests and hereby consent to submit to such tests as may be required. The location of the doping controls will be announced at the event. In default of appearance to the control or in case of refusal would be considered a positive test result. I acknowledge that in the event of the doping test being positive, I shall be disqualified from the event and my positive testing status shall be referred to my relevant controlling body for disciplinary action. I acknowledge that I can be banned from any future Zurich Marathon races.
- ✓ I hereby commit that I do not use any forbidden agents to improve my athletic potential. Furthermore, I guarantee that I only use pharmaceuticals which are prescribed by a doctor and do not in any way alter my performance. I also agree to provide my doctor's contact details at any stage deemed necessary to the organizer.
- ✓ I agree that my data may be used to send newsletters and SMS. I also agree that the data mentioned in my registration may be used for the purpose of the event and sponsors, provided that the applicable data protection law allows this. Without written notification to ZH Marathon GmbH, Uetlibergstrasse 111, 8045 Zurich, info@zuerichmarathon.ch up to one week after the event, your personal data may be passed on for services or advertising purposes in connection with the event. The consent to the transfer of data to third parties can be revoked at any time.
- ✓ My data will only be used for promotion and information about the Zurich Marathon events. With my participation I am automatically registered for the Zurich Marathon newsletter. It is my responsibility to provide the race management with a valid email address. I understand and accept that electronic communication via email is the official communication channel for the race.
- ✓ I assure not having any Covid-19 symptoms and not have been tested positively during the past two months.
- ✓ I assure to comply with all organizational and public protective measures, as well as with the Race Booklet, the contents of which I have fully understood.
- ✓ The organizer excludes any liability with regard to a Covid-19 infection resulting from the participation in the race.

The organizer reserves the right to change or modify the basic information or cancel the race because of force majeure or due to official orders. Entry fees will not be refunded in case of cancellation of the race. Further claims cannot be asserted.

Swiss law is applicable, place of jurisdiction for possible disputes is Zurich.

I have read the waiver, release and indemnification form and further confirm that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
